In August, 2012, the town of Oak Creek Wisconsin was rocked by hate when six worshipers at a local Sikh Temple were killed by a white supremacist during prayer services. “Waking in Oak Creek” tells the inspiring story of how the community responded to one of the deadliest hate crimes in recent U.S. history, and worked together with law enforcement to overcome tragedy and stand up to hate (film length 33min).

Join in a discussion of Oak Creek’s empowering response to the tragedy at the Sikh Temple of Wisconsin, and ways in which law enforcement and the community can work together to create a united front against hate. Representatives from the United States Attorney’s Office, Fresno State Ethics Center, Fresno State Department of Criminology, College of Social Sciences, Sikh Council of Central California, Islamic Cultural Center of Fresno, Fresno Police Department, Fresno County Sheriff’s Office, Fresno County District Attorney’s Office, Federal Bureau of Investigation, and the Alpha Phi Sigma National Criminal Justice Honor Society will be there.
